

## TERMS AND CONDITIONS

1. Booth reservations must be made in advance of the Shelter Dogs Rock event. A 50% deposit at the time of the booth selection is required to guarantee specific space. This contract is non-cancelable. Deposit and payments on this contract are non-refundable. Payments noted on this contract must be made on time. If payments are late, SPCA of Connecticut, Inc. retains the right to terminate this contract and resell the space.
2. SPCA of Connecticut, Inc will provide security throughout the entire event from initial set-up to final tear down. SPCA of Connecticut, Inc will not be liable to the exhibitor, his employees, agents, or guests for any damage, loss, or injury from fire, electricity, water, storm, riot, smoke, theft, or any other cause.
3. Exhibitor gives SPCA of Connecticut, Inc the right to use their name in Shelter Dogs Rock advertising.
4. All displays must remain completely setup and manned for all hours of the show, up to and including 6pm on Sunday. Early teardown is NOT allowed. Violation of this rule will subject the exhibitor to a \$500 fine and automatic non-renewal of space for future Shelter Dogs Rock events.
5. TOTAL COST OF BOOTH MUST BE PAID BY March 15th, 2010. ALL EXHIBITORS PAYING AFTER THE DEADLINE ARE SUBJECT TO PAY A 10% LATE CHARGE BASED ON THE TOTAL AMOUNT OF THIS CONTRACT. SPCA of Connecticut, Inc reserves the right to hold a company's inventory in the event of non-payment due SPCA of Connecticut, Inc for rent of tables, electric, decorator items, or monies due.
6. All exhibitors must be set-up and ready for business one hour prior to the show. All exhibitors arriving late for their designated set-up time will be subject to a new set-up time approved by SPCA of Connecticut, Inc. NOTE: EXHIBITORS WILL NOT BE ALLOWED TO SET UP ANY DISPLAYS OR MERCHANDISE IF ALL RENT AND MONIES DUE PER THIS CONTRACT HAVE NOT BEEN PAID IN FULL OR BEFORE March 15, 2010.
7. All products and services to be sold must be listed in writing on an attached sheet that is subject to final approval by SPCA of Connecticut, Inc. SPCA of Connecticut, Inc reserves the right to stop any sales of products not approved on the list with this contract. Failure to cease in sales of unapproved products or services will subject exhibitor to immediate removal from the show.
8. No product exclusive will be honored unless specified in this contract and approved by signature of the current Director of SPCA of Connecticut, Inc.
9. Devices that produce sound must be operated so as to not disturb other exhibitors. SPCA of Connecticut, Inc will determine the acceptable sound level.
10. It is agreed that any litigation regarding this contract shall be litigated in the appropriate Court in the State of Connecticut.
11. Participation in the Shelter Dogs Rock event is subject to final approval by SPCA of Connecticut, Inc. Subletting or sharing of space in any form is prohibited unless explicitly written in and signed by an authorized SPCA of Connecticut, Inc representative.
12. SPCA of Connecticut, Inc reserves the right to resell and cancel any contract not paid in full by March 15, 2010. Deposits and payments on the contract are non-refundable and will be considered payment for resale cost if the contract is resold due to failure of the exhibitor to pay in full by March 15, 2010.

13. Exhibitor agrees that commencing on the date of occupancy provided in this lease agreement, and thereafter during the period of occupancy, shall maintain such insurance in the amount of \$500,000.00 as will protect exhibitor, SPCA of Connecticut, Inc, and the Connecticut Expo Center, its members and staff from claims under workers' compensation Acts and other Employee Acts; from claims for personal injury, including death, and from claims for damages to property which arise out of or results from exhibitors' operations under this lease. Exhibitor shall provide SPCA of Connecticut, Inc at least forty-five (45) days prior to the dates of occupancy in this agreement, with evidence that it has comprehensive general liability insurance for bodily injury and property damage from a solvent company licensed to do business in the State of Connecticut.

14. The responsibilities of SPCA of Connecticut, Inc are limited to those listed within this contract. SPCA of Connecticut, Inc. shall not be held liable for any promises made by any of its representatives in the event of nonpayment; this contract becomes the sole responsibility of the signer.

15. SPCA of Connecticut, Inc agrees to advertise the Shelter Dogs Rock sufficiently using TV, radio and print media. Use of the name SPCA of Connecticut, Inc or the Shelter Dogs Rock trademark without written approval by SPCA of Connecticut, Inc will be cause for removal from the Shelter Dogs Rock event and immediately voids this contract. Any use of the name SPCA of Connecticut, Inc or the Shelter Dogs Rock in advertising or promotion at any time by a contracted exhibitor must be approved by SPCA of Connecticut, Inc.
